

Guidelines for Volunteers

Please follow these guidelines as you prepare to come to the coast to work.

- ★ Each group is responsible for obtaining a medical release form for each participant and providing a copy for North Mission Builders while on site.
- ★ Meals and lodging will be provided at a cost of \$20 per day.
- ★ This will consist of 3 meals, one of which being a sandwich lunch.
- ★ Bring your own bedding (sleeping bag, cot/air mattress, bed linens, towels).
- ★ Some showers may be outside, so you may want to bring a swimsuit/cover-up/shorts to wear back and forth ...also shower shoes.
- ★ Each group is responsible for providing their own beverages while working on the job site.
- ★ Clean up after yourselves. Before you leave, please clean the bathrooms, sleeping quarters, and kitchen. Take out garbage and leave no food in the refrigerator. Leave it like you found it...OR BETTER!
- ★ Follow all guidelines given by the church contact. Each church has their own rules and regulations about use of their facility.
- ★ If there is a worship service at your facility during the time of your stay, it would mean a lot to the church members if you would attend.
- ★ As you are packing up to leave, designate someone to check behind your team to make sure nothing is left.
- ★ As a general rule, treat your host church as you would your own.

North Mission Builders Release and Indemnity Agreement

I do hereby represent and acknowledge that I am volunteering for North Mission Builders for the purpose of helping in "Rebuilding Churches, Homes and Lives for God's Kingdom"; that the work may at times be hazardous, physically demanding, dangerous, and stressful; that vehicles transporting me and other volunteers will be operated by volunteers, who may not be professional drivers.

I recognize and acknowledge potential accidents at the disaster site, in or about the living, sleeping and eating areas, or during activities of the disaster relief team; am fully aware of possible injuries or death to members of the disaster relief team, including myself.

Therefore, I desire to protect, release, acquit, indemnify, and hold harmless the North Mission Builders, North Albemarle Baptist Church, the Mississippi Baptist Convention Board, the Gulf Coast Baptist Association and others as set forth below, from any and all claims, injuries, damages, losses, expenses or attorney fees incurred by me, my heirs, administrators, executors or assigns arising out of or related to disaster relief mission projects. This excludes any and all willful negligence, malicious and/or criminal intent which brings personal or physical harm to any individual.

For and on behalf of myself, my heirs, administrators, executors, assigns and all other persons, firms or corporations, I do hereby agree to indemnify the North Mission Builders, North Albemarle Baptist Church, the Mississippi Baptist Convention Board, the Gulf Coast Baptist Association, and others as set forth below and to release and discharge from liability all other persons on the disaster relief team with me, those who notified, selected or assigned me to the said team, the North Mission Builders, their site coordinators, the Mississippi Baptist Convention Board, their employees and representative, successors or assigns, the Southern Baptist Convention, and the Gulf Coast Baptist Association from any claims, demands, damages, actions, causes of actions which I, the undersigned, have or may hereafter, and on account of, or any way growing out of injuries or damages both to persons or property resulting or that may hereafter result from disaster relief mission projects.

I also understand that as a volunteer, I am expected to have insurance in case of accident, injury or illness; that no insurance coverage is provided to me or other volunteers by the North Mission Builders, North Albemarle Baptist Church, the Mississippi Baptist Convention Board, or the Gulf Cost Baptist Association; and that personal liability is my responsibility.

This waiver, release and indemnity agreement is fully understood by me and I enter the same willingly for the purpose herein above stated.
